### **Immigration, asylum and detention news**

#### **Independent Leading article: Talking sense on immigration**

The decision by the Mayor of London, Boris Johnson, to commission a study into the impact of an amnesty for illegal immigrants has not gone down well in Westminster. Mr Johnson's party leader, David Cameron, has refused to endorse the idea, and the Immigration minister, Phil Woolas, has described Mr Johnson as both "naive in the extreme" and a "nincompoop".

Behind this bluster, however, lies the fact that the present Government policy towards irregular migrants manages to be inhumane and economically inefficient. Migrants are left without access to basic health services and the Treasury is denied their tax contributions. These issues are especially pressing in Mr Johnson's jurisdiction of London, where more than half of the UK's estimated 700,000 illegal immigrants live. Full article at:

### **Detainee's property – follow up**

In response to the new regulations about property (the 20 kg rule), a list of concerns, drawn up by GDWG was presented to UKBA at a DUG meeting. It was not clear how this would work in practice and reports from ILRs since suggest there is much variation – and confusion - across the estate. Of particular concern was how detainees can manage their property if it is not allowed into the removal centre, or if it is, and what facilities exist for detainees to sort their property when they are in detention. The next DUG meeting is on 12th January and it would be good to present any difficulties and inequalities in the system. Please send any comments you have to me and I will present them at the next DUG meeting.

### **Evidence to the Committee for the Prevention of Torture and Inhuman and Degrading Treatment**

Avid, together with Medical Justice, LDSG, Barbed Wire Britain, Yarlswood Befrienders, and BID were delegates from the ARC Detention Users Sub Group to give evidence to this committee. The oral submissions followed the written one and highlighted detention of children, unlimited long term detention, effects of detention on mental health and complaints. It is unlikely that there will be a written report until late 2009 and then only after the UK Government has responded and agreed to publication.

### **Foreign National Prisoners Workshop on 8th November**

Steve Simmons (ILPA) Jerome (LDSG) and Steve Mason (DAS) gave an interesting and informative workshop covering the background - information and statistics; legislation – deportation, appeals, removals and leave to remain and visiting in prisons with reference to end of sentence and removal. Notes on these topics will be available shortly on the website.

### **Return of Somalis**

The European Court of Human Rights has recently stated, in a letter to Wilson and Co, Solicitors, of 21 October that it is adjourning all appeals against expulsion to Somalia until a series of appeals in the UK courts have been decided. The Home Office has appealed against the decision in a country guidance case (HH & others Somalia CG[2008] UKAIT00022) that there is a real risk in returning anybody to Mogadishu !!

Meanwhile the protection against removal provided under Rule 39 of the ECtHR to all those who have appealed to the court remains in place.

### **Something more cheering - Judges can be Forthright !**

Miss M came to UK on a student visa and married, quite legally, a settled partner. While her visa was still valid, she applied for leave to remain as a spouse and for leave for her daughter to remain with her. This was refused solely because there were insufficient funds in her bank account to cover the cheque when presented. She resubmitted the application but was again rejected because, due to delays, her leave to remain had then expired. She applied for Judicial Review. Mr Justice Sullivan was not impressed by the way the Home Office had conducted the case. While agreeing that the decision was in accordance with the letter of the rules, he concluded that to return Miss M and her daughter to Jamaica at considerable public expense solely for the purpose of her applying to return to UK at considerable expense to herself was "manifestly disproportionate and unreasonable" He went on to say "This is a classic example of a thoroughly unreasonable and disproportionate, inflexible, application of a policy, without the slightest regard for the facts of the case, or indeed elementary common sense and humanity. Such an approach diminishes, rather than encourages, respect for the policy in question."

He quashed the Home Office decision and said "I hope that a little common sense and humanity will prevail when this case is reconsidered"
